Cats – 10 years. Dogs – 8 years or 5 years (For some breeds this will be 5 years. If your dog is one of those breeds, this will be highlighted on your certificate of insurance).

**Lifetime** policies cover vet fees for new illnesses and accidental injuries up to a maximum amount which is reinstated each year.

Your premiums are only fixed until each renewal, and are likely to go up each year. Like humans, our pets are more likely to be affected by illness as they get older. This means that every year, your insurance premium will increase even if you have not made a claim. There is no limit to premium increases, these increases could be significant to you.

With **Time Limited** policies, each condition is only covered for 12 months calculated from the first date of treatment or until the maximum benefit is paid for that condition whichever occurs first. After this, we will not make any further claims payments for that condition or any bilateral, recurring or related conditions.
